THIS AMENDMENT TO THE AGREEMENT MUST BE EXECUTED BY THE CONSULTANT OR ITS REPRESENTATIVE AND THEN APPROVED AS TO FORM BY THE CITY ATTORNEY BEFORE THIS AGREEMENT MAY BE EXECUTED ON BEHALF OF THE CITY OF BURBANK.

- 1.0 Purpose. Client and Consultant entered into a written agreement dated June 30, 2017 ("Agreement") for Consultant to provide application support services to manage, maintain and support Customer Care and Billing (CCB) and Energy IP (EIP) databases for a monthly fixed fee. Under the Agreement, Consultant also provides additional programming integration work to support external systems on a limited time-and-materials basis. Due to unanticipated project demands, Client and Consultant desire to enter into this First Amendment to the Agreement ("First Amendment") to amend the Agreement to extend the Term and increase the Cost of Service to provide for additional ongoing integration services.
- **2.0** Amendment to Term. The Term of the Agreement is hereby extended from June 30, 2018, to July 31, 2019.
- Amendment to Scope of Services. The Scope of Services (attached to the Agreement as Exhibit "A"), is hereby amended by adding the additional services listed on the "Supplemental Scope of Services" attached hereto as Exhibit A-1. The initiation of Service by the Consultant will commence upon receipt of a written notice from the Designated Official authorizing Consultant to proceed, and only to the extent of such authorization. The services of the Consultant shall include the making of all investigations, studies, and analysis required by the conditions involved in each request of the Designated Official.
- 4.0 <u>Amendment to Cost of Service and Schedule of Compensation</u>. The Cost of Service is hereby increased from \$750,000 to a not-to-exceed amount of \$1,155,000.00. Additionally, the Schedule of Compensation (attached to the Agreement as Exhibit "B"), is hereby amended by adding the additional not-to-exceed compensation amount as indicated on the "Supplemental Schedule of Compensation" attached hereto as Exhibit B-1.
- **Ratification of Professional Services Agreement.** All other provisions of the Agreement dated June 30, 2017 not inconsistent with this First Amendment shall remain in full force and effect.

## SUPPLEMENTAL SCHEDULE OF COMPENSATION

The Schedule of Compensation (attached as Exhibit "B" to the Professional Services Agreement dated June 30, 2017) is hereby amended by increasing the not-to-exceed amount for all other services not covered by the flat monthly fee, from \$200,000 to \$605,000. Consultant shall submit invoices to City in accordance with Section 3.0 of the Agreement, and shall be paid for these additional services on a time and materials basis at the rate of \$205/hour.

Specifically, the services listed in the Supplemental Scope of Services attached to the First Amendment as Exhibit "A-1" shall be paid for according to this Supplemental Schedule of Compensation.
